Re: FMAP Membership Fee for the calendar year 2011

This is to inform you that Annual Subscription for FMA is due therefore, all FMAP Members are requested to pay their Annual Subscription as per the following revised membership structure, unanimitously approved in the last Annual General Meeting.

1. **International Members** **PKR 9,000/-**
2. **National Members** **PKR 6,000/-**
3. **Associate Members** **PKR 5,000/-**

- I. International Member shall possess all of the following qualifications
 - I. Must have been actively engaged international or locally in foreign Exchange and/or Money Markets or have been the person responsible for the management supervision and direction of such Trading Operations in their profession;
 - II. Currently must be carrying on their activities in a Scheduled Bank in above capacity;
 - III. Must have been so occupied for a minimum of five years at time during their professional career in a Scheduled Bank;
 - IV. However if an office bearer ceases to be an International Member but is eligible for national Member, the office bearer would continue the office till the next election.



2. National Member shall be individuals who are currently working as Foreign Exchange / Money Markets Dealers or Staff of the Treasury Front Office of Scheduled Bank, Development Finance Institutions, NBFIs, such individuals shall have working experience of at least one year.
3. Associate Members shall not carry any voting rights nor shall be appointed or elected as Members of the Executive Committee or Office Bearer of the Committee or the Board. However they may participate in the Association and receive notices and publications and may ONLY as observers at any General Meeting of the Association.

As FMAP is a registered Body, in accordance the said By-laws, it is binding on each and every member to strictly comply decorum and parameters set-forth. Any misstatement by the member will be answerable to the Executive Committee, who at its discretion may exclude the member from the association on the basis of breach of the provisions of its by Laws.

You are, therefore, requested to submit the information vide attached membership form through your Treasurer, along with cheque / pay order made out in favour of "Financial Markets Association of Pakistan" and arrange to deliver the same to the under undersigned latest by **16th April 2011.**
